

ENGLISH CHARGER MAP USB-C® Magnetic Charging Adapter Charging Contacts Lumectra Touch Button LED Bar



CHARGER MAP

SETUP



 Connect one end of the included USB-C cable into an available USB-C port on the PS5® console and connect the other end into the USB-C power port of the charging station.

Once connected, the LED bar will light up in the last used settings.



 Connect the USB-C magnetic charging adapter into the USB-C port of the PlayStation Portal™ remote player.





remote player on the charging station, making sure that the charging contacts are lined up with the bottom of the USB-C magnetic charging adapter.

The LED bar on the charging station will indicate charging has started by flashing or breathing orange depending on mode.



4. Lift the PlayStation Portal™ remote player off the charging station when you are ready to play.

NOTES:

- For best performance, use the cable provided to power the charger.
- When not using the PS5 console as a power source, ensure the charger receives at least 15 watts of power.
- Please read the Lumectra Lighting section for details on the LED bar functions.

LUMECTRA LIGHTING The charging station features multiple Lumectra lighting modes.











STANDARD

In **Standard** mode, the charging station LED bar will display the following:

Solid White: Charging station has power.

Breathing Orange: Charging station is charging the PS Portal™ remote player.

Solid Blue: The PS Portal™ remote player is fully charged.

CYCLE

In Cycle mode, the charging station LED bar will flow through a series of colors, gradually transitioning from one color to the next.

WAVE

In **Wave** mode, the charging station LED bar will flow through a rainbow array of colors from left to right, displaying multiple colors at a time.

PULSE

In Pulse mode, the charging station LED bar will fade in and out through a series of colors, displaying one color at a time before moving to the next.

OFF

In **Off** mode, the charging station LED bar will not display any lighting.

NOTE


In Cycle, Wave, Pulse, and Off modes, the LED bar stays in the selected mode but will indicate charge status as follows:

When the remote player is placed on the charging station, the LED bar will flash orange 3 times before returning to the selected mode.

Once the remote player is fully charged, the LED bar will flash blue 3 times before returning to the selected mode.

CHANGE MODES

Tap the Lumectra Touch Button on the back of the charging station to toggle through the different modes: Standard, Cycle, Wave, Pulse, and Off.



ADJUST BRIGHTNESS

Hold down the Lumectra Touch Button to adjust the brightness. The brightness will continue to cycle while the button is held. Let go of the button when at the desired brightness.



NOTE:

To turn off the lighting, change the lighting mode to off.

TROUBLESHOOTING

Q: Why is the PS Portal[™] remote player not charging?

- A: Confirm the USB-C cable is properly connected to the charging station and the PS5® console.
- A: Ensure that no dust or debris is blocking the charging contacts on the charging station.
- A: Check your PS5® console power settings and ensure the USB ports are powered on when the console is in Rest Mode.
- A: Confirm the remote player is properly seated on the charging cradle.
- A: The remote player may already be fully charged.

Q: Why is the LED bar lighting off?

A: The charging station may be set to OFF mode. Tap the Lumectra Touch Button once to set the lighting mode to standard.

A: The brightness may be set too low to be visible in brightly lit surroundings. Hold down the Lumectra Touch Button to adjust the brightness.
